NIGERIAN INSTITUTE OF ADVANCED LEGAL STUDIES TO COLLABORATE WITH FOREIGN LEGAL INSTITUTES



Director-General, NIALS

n his assum ption of duty, Prof. Epiphany Azinge, SAN, Director General, Nigerian Institute of Advanced Legal Studies. left no one in doubt as to his determination to reposition the Institute such that it meets the aspirations of

its founding fathers but to also justify its 30 years of existence as an apex legal body.

The Director General in facing this challenge undertook a visit to the United Kingdom to seek collaboration with similar Institutions there. The visit took him to the British Institute for International and Comparative Law, Institute of Advanced Legal Studies, School of Oriental and African Studies (SOAS) and the University of Southampton. The trip provided several existing opportunities for the Institute to tap in from the four Institutions.

For instance, the British Institute for International and Comparatives Law has agreed to collaborate with the Institute in the area of exchange programmes by accepting Research Fellows of the Institute, on short term basis, to undertake studies with them as well as research publications.

At the Institute of Advanced Legal Studies (IALS) in London, an understanding was reached to accept staff of IALS to participate at NIALS organized course in Legislative Drafting. The IALS further agreed to assist in enriching the Institutes Taslim Elias Library with books and requested that the Nigerian High Commission be contacted to facilitate shipment of the books without cost.

The Director General appreciated the re-link of the two Institutes and promised to sponsor two Librarians to undertake a study tour of the IALS

library. The IALS further agreed to sponsor projects initiated by Nigerian Institute of Advanced Legal Studies that have direct benefit for the two institutions.

The Director General also visited the School of Oriental and African Studies where there was an understanding to assist the Institute in the area of Islamic Law by taking up the challenge of occupying a Professorial Chair in Islamic Law.

The Head of the School of Law, Prof. Badare, promised to visit the Institute next year when a Memorandum of Understanding (MoU) will be signed binding their collaborative efforts with Nigerian Institute of Advanced Legal Studies.

The SOAS extended invitation to Nigerian Institute of Advanced Legal Studies Research Fellows to contribute articles for publication in the SOAS Law Journal.

At the Southampton University, the Director General met with another Nigerian, Dr. R. Nwabueze, a leading Scholar in Bio-Technology Law. He encouraged the Institute to take advantage of the many Nigerian scholars abroad for collaborative activities. He agreed to visit the Institute next year to take up appointment as a visiting scholar and a resource person for Institutes programmes.

The University of Southampton on its own agreed to partner the Institute in the area of maritime Law. To this end, a Centre for Maritime Law will be established at NIALS.

The visitations proved successful and actually united the Institute with these foreign Institutions. It is expected that fruits of the collaboration visit will begin to manifest in the year ahead.

It is to be noted that the Director General has in similar style, paid courtesy call on several agencies in Nigeria to seek collaboration. Some of these include the National Industrial Court, National Judicial Institute (NJI), Nigerian Communications Commission (NCC), the House of Representatives Committee on Judiciary, the National Security Adviser etc. These visits have great promise for the Institute in the years ahead.

Prof. E. Azinge and his Management team are poised to achieving the full mandate of the Institute so as to re-position it to perform its mandatory role as an apex legal research Institute.



PROF. AZINGE MEETS WITH THE HOUSE OF REPRESENTATIVES' HOUSE COMMITTEE ON JUSTICE.



he Director-General, Professor Epiphany Azinge, in pursuit of a good working relationship with the other organs of government was at the National Assembly with his team of Management staff, to meet with the House of Representatives' House Committee on Justice, headed by Hon. Henry Dickson Seriaka.

The Director-General informed the Committee that in line with the Institute's mandate to conduct research, organize workshops and seminars as well as conferences on different aspects of law and related disciplines, at local and international levels, the Institute also serves as a Think-tank for the government

on legal issues. Against this backdrop, it is currently working on a compendium on the Rule of Law, which would be ready by the end of the year.

He spoke of his passionate desire to restructure the Institute and return it to its former glory. In order to accomplish this, he stated that there would be need for him to employ more Professors of Law, amongst other things. He therefore solicited the assistance of the House of Representatives to show more understanding and be more sympathetic to approve generous funds as the present budgetary allocation to the Institute cannot meet with the challenges in present day Nigeria. The Director-General informed the House Committee that the Institute has long desired to have its own permanent site but because of lack of adequate funds this has not been possible. He passionately pleaded with the House Committee to show more understanding in this respect. He intimated the Committee that in the 2009 budget for example, the N2m allocated to the Institute Library is a far cry from what a Library of its status needs to meet with its obligations.

In response, Hon. Henry Dickson Seriaka assured the Director-General that the House would do all within its powers to see that the Institute is adequately funded in order to meet its mandate. On the issue of the Professorial Chair, the Chairman promised that the House Committee will meet and deliberate on the necessary steps to help the Institute.

DIRECTOR-GENERAL NIALS PAYS COURTESY CALL ON UNILAG



he Director-General of the Institute Prof. Epiphany Azinge, SAN, KSJ paid a courtesy visit to Prof. Tolu Odugbemi, FAS, NNOM, OON, the Vice-Chancellor of the University of Lagos, on August 4, 2009.

Prof. Azinge who had the Director of Research, Prof. Bolaji Owasanoye, Director of Studies, Prof. Deji Adekunle, Institute Librarian, Mr. T. O. Dada and Deputy Institute Secretary, Mrs. Nancy Jerry Imahiagbe on his entourage, stated in his speech that his visit was to solicit the Vice-Chancellor's restoration of what had appeared in recent years a communication gap between the leadership of NIALS and UNILAG.

The Director-General intimated the Vice Chancellor "that a good number of us at the Institute are Alumni of this great Institution and therefore stakeholders in the affairs of the University," stressing that the link between NIALS and UNILAG dates back to 1979 and has ever remained very cordial.

He added that the close relationship is such that many do not know that NIALS is an autonomous Institution. He expresses gratitude to the University Community for accepting NIALS Staff as part and parcel of the University whether at the School level, at the Health Centre, Senior Staff Club and even on issues of admission into the University.

Prof. Azinge pointed out that the Institute has traditionally reciprocated in kind, availing the Law Faculty students and staff unlimited access to NIALS Library unarguably the best equipped Law Library in Africa also complete take-over of one of our lecture

theatres and free use of our own auditorium as well as other facilities.

The Director-General said the visit was also to acknowledge the VC's leadership and authority in the environment; to solicit for a new beginning of mutual cooperation and understanding and consider the Institute as worthy partners in investment in education; and to request that the University graciously overlook any of the Institute's shortcomings over the years and plead that all past privileges taken away from NIALS be restored.


He also solicited the Vice Chancellor's approval for the following:

he Director-General and some members of the staff paid a courtesy call on the Executive Vice-Chairman of the Nigerian Communication Commission, Mr. Ernest Ndukwe on the 5th July, 2009. The Vice Chairman warmly welcomed Professor Epiphany Azinge, SAN and his entourage to the Commission Complex.

Prof. Azinge after introducing the team on his entourage, spoke glowingly on the establishment of the Institute and its mandate which includes overseeing activities of Post Graduate Studies in Nigerian Universities. The Institute, he said provides specialist training in Legislative Drafting and remains the only Institution providing such services in Nigeria. NIALS also advises the government on their policies through various researches conducted. He commended the Executive Vice-Chairman and the Commission on the achievements of NCC which is un-precedented in Africa and assured him of the Institute's support.

The Director-General spoke about the newly established *Centre for Media and Communication Law* in the Institute. This will help promote research and capacity building in

telecommunications. He stressed the desire of the Institute to pioneer a research tailored specially for the area of media and communication law in Africa.

The DG in his address appealed for collaboration between the Commission and NIALS. He appealed that the NCC leadership endow a *Professorial Chair in Communication* and further appealed for an opportunity to have a number of a NIALS Research Fellows serve an attachment with the Commission for 2-3 months.

In the Vice-Chairman's response, he acknowledged the level of development in the telecommunication industry and assured the DG of assistance in human capacity development. He further assured the Institute that:

- a. The Commission would be willing to have two NIALS Academic Research Fellows each year on attachment;
- b. NIALS Research Fellows would be welcome as, Resource Persons during training programmes organised by the NCC;
- c. With regard to the Professorial Chair, he promised to present a memorandum for consideration by the NCC Board.



S.M.A. BELGORE'S PROFESSORIAL CHAIR OCCUPIED BY PROFESSOR NNAMDI ADUBA

he Professorial Chair endowed by the distinguished former CJN Hon. Justice S.M.A. Belgore (RTD) has been occupied. At the close of the selection process, *Professor Nnamdi Aduba of the University of Jos emerged winner of the Professorial Chair.*

Professor Nnamdi Aduba a distinguished Scholar hails from Anambra State and was born January 21st 1955. He obtained his LL.B (Honours) Degree in 1978 from the University of Lagos and was called to the Nigerian Bar in 1979. In 1982, he received his LL.M. Degree.

He began his teaching career at the University of Maiduguri first as a youth corp member in 1979 followed by his appointment as a Graduate Assistant in 1980. Over the years, he rose through the ranks at the Faculty of Law, until he became a Lecturer 1 in 1990.

In 1990, he was made a Senior Lecturer at the Faculty of

Law, University of Jos. He became an Associate Professor of Law in 1993 and a substantive Professor in 1999. In the course of his teaching career, he has held several positions amongst which are: Pioneer Dean, Faculty of Law, Nassarawa State University, Keffi, 2002-2003; Acting Dean Faculty of Law, University of Jos, May 2002 to November 2002 and a member Editorial Board, Lawyers Bi-annual, 1994 to date.

Professor Aduba's research interests include Constitutional Law, Family Law, Mass Communication Law, Nigerian Legal System and Criminology and Penology. He presently teaches Human Rights Law at Postgraduate Level and Constitutional Law and Family at Undergraduate Level. He also supervises postgraduate students at both the Masters and Doctoral Levels. Professor Aduba is widely published and has to his credit 16 chapters in Books, 21 Articles in Learned Journals, 5 published papers in Conference Proceedings and a Monograph. Professor Aduba is married with three children.

NIGERIAN INSTITUTE OF ADVANCED LEGAL STUDIES TO CONVOCATE PG STUDENTS IN DECEMBER 2009

he Academic Planning Board (an equivalent of the Senate of a University) has approved for the convocation of graduates of the Institute. This decision followed a recommendation to the Board by the Coordinator of the School of Postgraduate Studies, Mr. David Oluwagbami.

In arriving at this decision, the Board observed that although the Institute offers advanced studies at both the Postgraduate Diploma and Masters Degree Levels in Legislative Drafting, graduates of the Institute never had the opportunity of passing out in a ceremonial manner as it should have been.

The Board further noted that so far, the Institute has graduated two hundred and ninety Lawyers at both the Postgraduate Diploma and Masters Levels.

In approving the recommendation, the Board agreed that there was the need to accord certificates awarded by the Institute public acclamation and that could only be achieved when the certificates are presented to graduates at public/social events like the

Furthermore, it prepared lawyers for the critical role of advisers to major players in the economy and the use of precedents as well as current examples to illustrate the principles.

Conveyancing and Perfection of Instruments, Mineral Agreements, Dispute Resolution Mechanisms as well as Traditional Commercial Agreements. There were practical drafting exercises to the delight of the participants.

The opening and closing ceremonies were conducted by Professor Bolaji Owasanoye and Professor Deji Adekunle respectively on behalf of the Director-General, Prof. E. C. Azinge, *SAN*. Professor Owasanoye commended the participants for attending the course and pledged the Institute's preparedness to

ADVOCACY FOR BENCHMARKING IN THE NIALS TASLIM ELIAS LIBRARY, LAGOS

he Library and information science over the years have evolved as a body of knowledge with an on-going development of sets of theories which are either peculiar or multidisciplinary in nature. Again, the library and information services all over the world have been guided by basic similar procedures though some characteristics may be peculiar to specific groups of libraries (special libraries delineated by user focus). However, with information explosion, cultural diversities, globalization in relation to information dissemination, accessibility, usage and the attendant financial implications, variations are noticeable in library practice and management.

The foregoing therefore throws in a major challenge which is that of standardization of library procedures and management practices most especially amongst libraries of similar mission statements. In some cases, some international library associations have succeeded in producing standardization documents/instruments which are modifiable and have been serving as guidelines for different categories/areas of library operations over the years. Yet, differences in operations are noticeable from region to region or amongst libraries of diverse multicultural settings.

Again, many libraries are in the dilemma of evaluating their services as there are no fixed guidelines to help in this respect. The used for regular and periodic evaluation of library services is not an option, it is an exercise to be done out of necessity. Internal assessments of libraries are desirable but could be deficient when they do not conform with external and/or international standards. Hence, the need for conducting library benchmarks with a view to charting the status of an individual library and as a means of charting new course of action.

This paper therefore seeks to make a case for the institution of benchmarking in the Nigerian Institute of Advanced Legal Studies (NIALS) Library, Lagos with a view to boosting performance.

BENCHMARKING: WHAT IS IT?

The origin of the term benchmarking is traced back to the business environment. It is a concept that has been so used in the terrain for years and is now being imported into other circles, the library and Information field inclusive (White, 2002).

The literature of benchmarking though terse, has attempted some functional definitions of the concept. Each of the definitions advances its own leanings and lays emphasis on different but related aspects of benchmarking.

The first category of definitions simply defines the concept of benchmarking with emphasis on it being a tool comparison amongst similar organizations. This is exemplified by the following submission:

Benchmarking is an ongoing, systematic process for measuring and comparing the processes of one organization to those of others that exhibit functional "best practices". (White, 2002:17).

Another view in this same category of definitions gave the following summary:

Benchmarking refers to the practice of comparing on a measurable scale the performance of a business operation to a similar operation in other organizations. (Robbins, 1997 as cited by Adegboye, 2007: 37).



RATIONALE FOR INSTITUTION BENCH-MARKING IN THE NIGERIAN INSTITUTE OF ADVANCED LEGAL STUDIES LIBRARY

The second school of thought while maintaining the comparative feature presents benchmarking as a tool of self evaluation:

Benchmarking is a self-improvement tool for organizations to compare themselves with others to identify their comparative strengths and weaknesses and learn how to improve. (Association of Commonwealth Universities, Registered Charity No 314,137,2005).

To buttress the second category definition, benchmarking has also been classified as a kind of research design under evaluation research (Powell, 2006).

Thirdly, the art of benchmarking has further been linked with the effort of an organization to adopt best practices in business orientations. Hence, the following opinions are also relevant: Benchmarking is a systematic process for identifying and implementing best or better practices. (Business Performance Improvement Resource (BPIR), 2007).

Benchmarking is an activity where organizations continuously engage in self-study and compare themselves with the leaders in their field so they can identify, adapt and apply significantly better practices. (Archived Information, 1999: 1).

Benchmarking is the process of measuring an organization's internal processes, then identifying, understanding and adopting outstanding practices from other organizations considered to be best in class, (The Benchmarking Exchange (TBE), 2009).

Fourthly, benchmarking also exhibits the features of a organization creating a competitive business niche for itself as we as setting standards for others to follow. This view is substantiated below:

Benchmarking is the process of determining who is the very best, who sets the standard (Reh, 2009:1). On the fifth plane, the benchmarking art also hinges on the premise of managerial and strategic activity as expressed below:

Benchmarking is a management technique to improve performance (Office of Government of Commerce (OGE), Retrieved, 2009).

In summary, the deductions made by this presentation from the various definitions above are that benchmarking is management/strategic technique employed for healthy comparison self evaluation, adoption of best practices, creation of business niche and setting of standards with a view to improving performance organization within similar or related business environment.

THE BENCHMARKING PROCESS: CONCEPTUAL FRAMEWORK: The framework of benchmarking is better consolidated with a modified graphic representation of Choo, (Retrieved 2007) and adopted by Nicholas, 2007:7



TYPES OF BENCHMARKING

Literature has identifies two types of benchmarking. These are informal and formal benchmarking.

(a) INFORMAL BENCHMARKING:

This refers to the casual process of knowing or learning about practices of others in familiar set-up or environments. This includes among others talking to colleagues and learning from their experience, consultations with experts on a particular process, networking with people through conferences, seminars, internet fora and use of online databases and websites. (Business Performance Improvement Resource (BPIR) 2007)

(b) FORMAL BENCHMARKING:

This refers to a formalized method of inter-organizational comparison of their performance levels in order to identify opportunities for improvements/setting performance targets (known as performance benchmarking) or the identification of high performer in an industry for studying through mutual beneficial agreement that follows a benchmarking code of conduct (known as best practice benchmarking).

THE PLACE OF THE INSTITUTE IN LEGAL RESEARCHINNIGERIA.

The Nigerian Institute of Advanced Legal Studies is one of its kind in the nation. An initiative conceived and officially commissioned in March 1979 and was intended to be "Nigerian Apex Institution in Law" (Nigerian Institute of Advanced Legal Studies, 2006) Enabled by Section 4 of the Nigerian Institute of Advanced Legal Studies Act, Cap 310, Federation, 1990, the mandate of the Institute includes, among others, the provision and dissemination of information for the support of as well as supervision of post graduate work in law; conduction of research; organization of local and international workshops, seminars and conferences; regular publication of relevant books, journals, seminar and conference proceedings, and cooperation with cognate institutions such as the Nigerian Law School in matters relating to law reform and development, etc. (Nigerian Institute of Advanced Legal Studies, 2006).

In line with the foregoing, the Institute was designed to be the national benchmark for Advanced Legal Studies in the nation. To this extent, how far has the establishment gone in the pursuit of its mission mandate especially in the area of dissemination of legal information? The position and role of the library in the survival of the institute as the Apex law research agency is undoubtedly germane in this respect.



RATIONALE FOR INSTITUTION BENCH-MARKING IN THE NIGERIAN INSTITUTE OF ADVANCED LEGAL STUDIES LIBRARY

RECOMMENDATIONS: The following are desirable guidelines to be taken into consideration in the execution of the benchmarking activities:

- (A) INSTITUTION/ADOPTION OF THE BENCHMARKING POLICY: The first step in the process of benchmarking is its formal adoption as a management tool for the analysis and evaluation of library processes with the ultimate vision of ensuring improvement in performance. With this in place, the library officially regards the practice as part of the obligations of the establishment.
- (B) TEAM MEMBERS: It is also desirable for library to constitute a benchmarking team for effective execution of the project. In doing this, the establishment could draw from the experience of corporate organizations who have Research and Development (R&P) Units to coordinate the activities. On the other hand, the team could be made up of representatives from different sections of the library and membership can be reviewed from time to time. Again, services of professionals from adjunct or related disciplines outside the library may be solicited if so required.
- **(C) WHAT TO BENCHMARK FREQUENCY OF BENCHMARKING:** The library needs to decide on what to benchmark from time to time. It usually involves the design of regular benchmark indices that could be used repeatedly at various times for competitive analysis. It may be holistic or segmental or topical. This is equally tied to the determination of frequency of benchmarking activities.
- **(D) IDENTIFICATION OF BENCHMARKING PARTNERS:** There is the need to identify benchmarking partners to be engaged in benchmarking activities. It may also identify specific library process(es) and select partners from those acclaimed to have best practices in that area(s). For instance, benchmarking partners on the application may not necessarily be from the law library category only; it may require looking beyond the group. It is delightful to mention that the presenter had once attempted to open up a discussion on benchmarking partnership with the Institute of Advanced Legal Studies (IALS), University of London during the ruminative stint of this presentation (see Appendices I & II). Similar attempts can be made to draw up lists of partners from time to time.
- **(E) ANALYSIS OF DATA:** Data collection from the survey instrument or any benchmark partners should be duly analyzed to draw out research findings.
- **(F) COMMUNICATION OF RESEARCH FINDINGS:** It is desirable that research findings and conclusion drawn out from data collected be communicated to all members of staff within the

library system. This is expected to generate some reactions from stakeholders as well as inform the next course of action.

(G) REPORT OF THE BENCHMARKING OUTCOMES

An official report of the benchmarking outcomes needs to be made available by the library management to the library committee as well as the parent institution. The report could also be made available on the library managed web-site and/or the Institute's web-site as the case may be. It is an official declaration that benchmarking findings have been translated into policies.

(H) ADOPTION/INTEGRATION OF BENCHMARKING OUTCOMES: This is the final stage of the benchmarking process. It entails the translation of the policies arrived at into service(s). The outcomes are applied to the library management principles and services within the context of the aspects that were benchmarked with measurable expectations of improved performance.

CONCLUSION:

The retention of the title of the 'Apex Institute' in Advanced Legal Research in Nigeria is a very demanding one to maintain. The provision of an enviable Law Library Service of international standard is apparently germane to maintaining the locus using the benchmarking strategy. The inherent value of engaging in the exercise of today's thesis though may not be apparent now, will be discovered to be a worthwhile venture and legacy in the nearest future.

Finally, I wish to say thank you to the management of the Nigerian Institute of Advanced Legal Studies for the offer of

the sabbatical appointment and the library management for equally providing a convenient tambience to serve. To this august audience, I also say thank you very much for your attention and may God bless you all.



Welcome address:am highly delighted to welcome you all to the 22 Annual General Meeting of our great Society, Lglory be to God Almighty. A year ago, in this same hall, with your votes you entrusted the pioneering of the management of this society into the hands of sixteen honourable men and women including my humble self. I am happy and pleased to inform you that we proved to be a set of wonderful and dedicated people who did everything possible to maintain the progressive records of the Society. I, therefore, present hereunder the result of our operation the year 2008. It would be recalled that the business world is faced with harsh operating environment variously called economic meltdown, Global economic recession and is experiencing Economic quagmire which had started during the period under review, that is, the purchasing power declined while the inflation rate increases and this has a devastating effect much on us that are fixed income earners. It was Booker T. Washington who once said that "success is not measured by the height one attains but by the obstacles one overcomes in their attainment" It is my great pleasure to report that despite these aforementioned problems, by the Grace of God, our Society continue to make progress in its operations. The details of Income and Expenditure will be read by the Treasurer in his report. This is an upward movement of Net surplus by N732,092.69, while the dividend per naira moved from NO.04 in 2007 to NO.0463 in 2008.

INVESTMENT: The Society proposed within the period to increase our investment in fixed Deposit, we are sure of better Investment Value in the next AGM.

ABUJA LAND: A loan of N250,000.00 has been given for the fencing of the land and we hope members will start to build structures on their plots and take physical possession as soon as possible.

OGIJO LANDED PROPERTY: It is encouraging to note that members have started erecting structures on their plots. Allottees are advised to continue to put structures on their plots. A supervised loan of N100,000.00 may be granted to any member who is qualified based on his/her net Income and savings. We also hope to obtain the outstanding documents -Certificate of Occupancy as soon as the Governor gives assent. It is heartwarming to report that numbering of the pillars would be completed.

LOAN MATTER

I am using this opportunity to remind us that our Maximum Credit Limit (MCL) remains one and half of our total savings as at the date of issuance of such loan. Also mention must be made of the fact that our Loan repayment period still stands at 24 months for regular loan, while Electronic/Special Loan is for 10 months. I enjoin you to adhere strictly to these rules, so as to allow issuance of loan to reach as many members as possible.

The principle of "settlement of one loan before applying for a fresh one" is much in vogue.

UNDERSTANDING THE FINANCIAL REGULATION GUIDING FEDERAL PUBLIC SERVICE IN NIGERIA




Government
Financial
Regulations is a handbook
that contains basic rules for
the operation and conduct of
government business,
especially the financial
system. The need for
accountability and
responsiveness in the
handling of business in both
public and private sectors has
been on the increase. In recent
years, the number and

monetary value of public activities has brought with it added demand for accountability.

Management and indeed employees need to render adequate accounts of their activities to the public. The general public requires accountability reports in order to assess the performance of those entrusted with public sector resources. Accountability concept is inherent in the governing process of any establishment. In Nigeria, there were and still are cases of fragrant violations of the established rules in the conduct of Government business during the military regimes and even during the Second Republic under President Shehu Shagari.

Former President Olusegun Obasanjo, on assumption of office on May 29, 1999, summoned all Senior Civil Servants (I was there), to the International Conference Centre, Abuja, on May 30, 1999 and expressed dissatisfaction with Civil Servants generally in almost all financial dealings of the government. He then directed on an immediate Review of the Financial Regulations (FR), which had not been reviewed or revised since 1976. He also directed that copies of the handbook be made available to Civil Servants. The handbook saw another revision in 2000, 2004 and 2006.

Copies of the handbook, *Financial Regulations December 2006* are available at the office of Government Printer and Newsstands. What I am trying to do in this article is to bring to management, staff and the general public, a summarized extract of the Financial Regulations (FR), along with other related "sister" documents or enactments in the hope that NIALS staff would be better informed. It is my sincere hope that NIALS management and staff will become better managers of resources and it will also benefit members of the public and other curious readers. The article will benefit all involved in the financial management cycle depicted below:



FINANCIAL REGULATION (FR)

The Financial Regulation Handbook which is an offshoot of the Financial Control and Management Act 1958 was first revised in 1976, then 2000, 2004 and 2006. The handbook is aimed at producing rules that would guide Public Expenditure in consonance with prevailing fiscal policies on probity, transparency and accountability. Understanding the provisions of the document is mandatory for Ministers, Accounting Officers and Accountants and Auditors, while all public officers are enjoined to acquaint themselves with these provisions thereof to be properly guided and avoid falling victim of the law. Financial Regulations are by no means superior to the Constitution, which contains vital issues in the operation of Government business. The document now revised to 32 chapters, has Appendices, Standard Forms, etc. A summary of the Financial Regulations by chapters has the following:

ALLOCATION OF REVENUE

The Act prescribes the basis for distribution of revenue accruing to the Federation Account between Federal and State Governments and the Local Government Councils in the State. It contains the formula for distribution amongst the States interse, the proportion of the total revenue of each State to be contributed to the State Joint Local Government Account, and for the purpose of connected therewith.

The distribution is done in stages as follows:

a.	Distribution of the Federation Account etc				
	- The Federal Government	56%			
	- The State Governments	24%			
	- The Local Government	20%

b. Formula for distribution between the Federal and State Government.

- The amount represented by the 56% and allocated to the Federal Government is further stated as follows:

- Development of National Resources TOTAL	3.00% 56.00%
- Stabilization account	1.50%
- Federal Capital Taxation	1.00%
- General ecological problem	2.00%
- Federal Government	48.50%

- **c.** the 24% allocated to States is shared to all States of the Federation using the following structure:
- (i) The Land Mass (also known as the Proportional Area Size PAS) as specified in the Act
- (ii) The terrain (wet lands/water bodies, plains and high lands)
- (iii) Education as a parameter for allocation to Social Development Factor (SDF).

The Act also provides a proportion of revenue to be paid by each State to State Joint Local Government Account. Also the Accountant-General of the Federation should meet monthly with State Accountants-General to Iron out issues and the Act specifies that a report be made by the Accountant-General of the Federation after collecting retirements from the Accountant-General of each State of the Federation.

FINANCE CONTROL OF MANAGEMENT ACT OF 1958 (AS AMENDED)

This is one of the oldest Acts dealing with procedures in the public funds. The latest amendment deals with general supervision and control (Part I). Consolidated Revenue (Part III), Enactments (Part II), Legislation Authorization of Expenditures (Part IV), while Part V deals with other public funds, later interests and rules for management of funds. Part VI specifies the Annual Accounts of all funds. There are also three Schedules on similar subjects specified in the Act.

TRADE UNIONS ACT 2005

The Act amending the Trade Union Act, provides for among other things, the democratization of the Labour movement through the expansion of opportunities for registration of Federal Trade Union, as well as the granting of freedom to employees to decide which unions they wish to belong to.

FISCAL RESPONSIBILITY ACT 2007

The main thrust of the Fiscal Responsibility Act which came into Law in 2007 is to among other things:

- a. Ensure sound financial management by all tiers of government.
- b. Commit all tiers of government to a set of efficient rules for economic management.
- c. Standardize the planning and control of public expenditures.
- d. Encourage stable price and exchange rate as well as sustainable growth.
- e. Facilitate parliamentary and public sanitary of economic and fiscal information and plans.
- f. Bring a long term as well as annual focus to budgeting.
- g. Minimize risk and actualize in government fiscal operations.
- h. Bring harmony between fiscal and monetary

- policy, and
- i. Keep Nigeria's debt sustainable.

The Fiscal Responsibility Act (FRA) has the potential of supplying the missing gap between the resources of this nation and her level of development. It has the capacity to reduce waste and management scarce resources and to carry the highest disillusioned citizenry along with managing of affairs of the nation. State government can easily adopt identical policies.

PUBLIC PROCUREMENT ACT

The Act, also known as Due Process Act was established by the National Council on Privatization and Bureau of Public Procurement as the regulatory authorities responsible for monitoring and overseeing of public procurement, harmonizing the existing government policies and practices by regulation, setting standard and developing the legal framework and professional capacity for public procurement in Nigeria.

In addition, the Bureau which is charged with the suspension of the implementation of the provision of the Act is further charged with the following:-

- a. Harmonization of existing government policies and practices on public procurement and ensuring proximity of accountability and transparency in the procurement process.
- b. The establishment of pricing standards and bench marks.
- c. Ensuring the application of fair, competitive, transparent, value-for-money, standard practices for the procurement and disposal of public assets and services and
- d. The attainment of transparency competitiveness and professionalism in the public sector procurement system.

In addition, household has been established as approval limits for the Director-General, Parastatals Tendering Board, Ministers and Ministerial Tenders Board, "No objection" clause by the Bureau of Public Procurement and the Federal Executive Council.

CONCLUSION

Understanding the Financial Regulation and related financial documents is the responsibility of all the management, employees, and the public. It is important that operators know this and avoid falling victim of the Law. There are various agencies like EFCC, ICPC, Code of Conduct and others charged with prosecuting defaulters. Ignorance of the Law is no excuse to committing any offence. Therefore, to be equipped with these provisions will help enhance and promote accountability and transparency.



STUDY YOUR BANK STATEMENT- It is Your Right to Know

INTRODUCTION

A bank statement is a summarized report of the customer's transactions at the bank for a particular period. The volume or details on the bank statement depend on the transactions by the customers.

Big and small customers are by right, entitled to a bank statement periodically. For the avoidance of doubt, a customer dealing in millions of naira at the bank is entitled to a bank statement just as a customer transacting in smaller amounts; a businessman should be given a bank statement just like a salary earner. Some banks however, will give bank statements only to current account holders.

In any case, it is desirable and necessary that you not only obtain your bank statement on monthly basis, but also study to know what it contains.

WHAT TO LOOK FOR IN YOUR BANK STATEMENT

Many customers are contented with just asking for their balances, but a careful analysis of the bank statement will satisfy the customer and give him assurances that the balance is indeed correct. The customer has to satisfy himself/herself that he/she knows exactly the type of amounts that go into his/her bank account. A bank statement will show transactions that the customer has authorize or withdrawals that he has knowledge of. Any discrepancies should be investigated immediately.

Discrepancies could be under or over the reported balance. If it is under, it could be that the balance falls short of expectation, if it is over on the other hand, it could be that the balance amount is more than what is expected. Either way, find out what happened. Depending on the volume of transaction, you can do this in a very short time or sit down and work out what is called *reconciliation or resolution* of the matter.

For a salary account, this looks a bit simple. You know your salary and the necessary deductions and what goes to your bank as the net figure. This figure is reflected on your pay slip and is the same figure that should go into your bank account. You should also confirm other amounts that go into your account. In this era of e-payment system, lodgment could be made into your account probably without the customer's prior notice. Just like in the case of salary, the staff should confirm from the Bursary department the exact amount sent to his/her account.

Withdrawals from the bank can be made through ATMs, issuance of cheques and *standing orders* to the bank. If you have taken *No Wahala or other loans* from the bank, you should also note the agreed monthly deductions or charges; ensure that only the correct deductions are made. Bank charges will also reduce your balance.

BANK CHARGES

The bank would normally charge your account for the

service it renders. The amount of charge would depend on the transactions made. However, the standard practice is to take commission as transaction (COT) at five naira in every one thousand naira withdrawn. In addition, value added tax (VAT) is charged on this COT, at the rate of 5%. For any one thousand naira withdrawn from the bank by you, the bank will device a total of N5.25 (ie COT N5, and VAT N0.25). These charges will increase as the total amount withdrawn increases. (See illustration below).

NB: Please note that withdrawals through the Automated Teller Machine (ATM) will attract bank charges in the same way as withdrawals by cheque.

FORMAT OF A BANK STATEMENT

A Bank Statement format will generally contain the following: Date, narration, debit, credit and balance.

A transaction will take place on a particular date which will be recorded and narration given. This transaction would either be lodgment, which will be recorded under credit column in your bank statement or it would be a withdrawal which will be recorded under the debit column. A lodgment is added to the existing balance to arrive at the current balance, while a withdrawal or debit is accordingly deducted to give a current balance.

MR. J. J. NIALS BANK STATEMENT EXTRACT FOR JULY 2009

The above statement is in respect of Mr. J. J. NIALS from a Commission on Trasaction (CoT) certain bank, for the month of July 2009.

An analysis of the statement shows that on $1^{\rm st}$ July, 2009, he had an opening balance of N1, 000.00 in his bank account. His salary amounting to N45, 000.00 was paid on 29th July, 2009 thereby increasing the balance to N46, 000.00. But the next day, he issued a cheque of N40,000.00 to withdraw this amount for his own use, thus leaving the balance of N6,000.00 in his bank account.

However by this withdrawal, Mr. J.J. Nials incurred a COT of N200.00 (ie. N5.00 in every N1000 of the N40,000.00 withdrawn). Value Added Tax of N10.00 (ie 5% of N200.00) was also charged by the bank the same day, thus leaving him with a balance of only N5,790.00 with the bank.

CONCLUSION

Don't just ask for the balance at the bank, collect your bank statement: study it and assure yourself that the bank statement contains *no wahala* element.


