NIALS Gets New Director-General

new Director-General has been appointed for the Nigerian Institute of Advanced Legal Studies. He is Professor Epiphany Chigbogu Azinge, SAN. By the letter appointing him as Director-General and signed by the Honourable Attorney General of the Federation and Minister of Justice, Mr. Michael Kaase Aondoakaa, SAN dated May 26th, 2009, he becomes the 6th

Director-General of the Institute. His appointment was with immediate effect and followed approval of same by the President and Commander In Chief of the

Armed Forces of the Federal Republic of Nigeria, Alhaji Umaru Musa Yar'Adua, *GCFR*.

His appointment followed the expiration of tenure of his predecessor in office, Professor D.A. Guobadia who had served the Institute for six years as Director-General.

Until his appointment, Professor Azinge, SAN was Director of Studies at the Institute. His tenure will run, as that of the Vice Chancellor of Nigerian Universities, for a single non renewable term of five (5) years.

Prof. Azinge is a man of immense learning, a scholar of repute, a teacher committed to human development and character moulding, he is a humble man whose field of study has not deterred him from rendering humanitarian service or engaging in philanthropic projects, His penchant for excellence and hard work is likely to influence positively on the fortunes of the Institute and staff.

Professor Azinge, 52 years of age, is a research professor of law and Senior Advocate of Nigeria. He is married to Dr. (Mrs) Valerie Azinge Ph.D and have four children.

THE MAN 'AZINGE'



Professor Epiphany Azinge, 52 years of age, is a man of immense learning, a scholar of repute, a teacher committed to human development and character molding. He is a humble man whose field of study has not deterred him from rendering humanitarian services or engaging in

philanthropic projects. He is indeed a man after God's own heart.

Born to Ibo parents in Asaba, Delta State, Professor Epiphany Chigbogu Azinge, SAN, KSJ, is married to Dr. (Mrs) Valerie Azinge and they have four (4) lovely children studying overseas.

When Professor Azinge emerged the best Youth Corper in the then Gongola State in 1981, it was evident that he was destined for great heights in the public service of this country. For his excellence during the NYSC year, President Shehu Shagari, was to endorse his exemplary conduct by presenting the National Merit Award for distinguished Youth Corper to him in 1982.

Expectedly, Professor Azinge joined the Faculty of Law, University of Benin as a pioneer staff in 1982 and rose to the rank of Associate Professor in record time. Apart from numerous publications to his credit, he has excellent teaching skills and administrative acumen which singled him out as a role model for staff and students alike. In no time, he became the Head of Department of International Law and Jurisprudence and later the Deputy Dean of Law. He was also a distinguished member of Senate of the University of Benin.

In 1993, Professor Azinge was invited to serve as Special Assistant to the Honourable Attorney General of the Federation and Minister of Justice. He represented Nigeria on numerous occasions at the sixth Committee of the United Nations in New York. He was personally credited with the idea behind the establishment of the National Human Rights Commission and the Failed Bank Tribunal. Over and above all these, he coordinated and orchestrated the activities of Nigeria's legal team on the Nigeria-Cameroun Boundary dispute. In this assignment, he was privileged to be one of the first Nigerian indigenous lawyers to appear in the World Court at The Hague.

Professor Azinge left the Federal Ministry of Justice and returned straight to his first love- teaching university students. After a brief stint at the University of Abuja as a Visiting Scholar, he finally joined the Nigerian Institute of Advanced Legal Studies as a Research Professor of Law and

was made the Director of Research. During his tenure as Director of Research, he championed the research study on **Judicial Integrity in Nigeria** – a research undertaken with the United Nations. It is a research work that has been widely acclaimed as the most expansive (considering the number of people interviewed) in Africa

In the course of propagating his teaching gospel and before his appointment as Director-General of the Institute, he also engaged himself in charitable teaching ventures at various higher institutions including the Nassarawa State University, Keffi and the University of Benin where he is a Visiting Professor of Law. In these two places, he teaches without charge. He also supervises LL.M and Ph.D dissertations without charge at the University of Abuja.

A graduate of the University of Lagos (1979), Nigerian Law School, Lagos (1980) and the London School of Economics, University of London (1986), Professor Azinge is an accomplished scholar. To his credit are over thirty (30) publications in local and international journals and books, several articles and presentations at Seminars and Conferences too many to document. He is an acclaimed expert in Electoral Law and Election Matters.

Amongst several awards and recognitions he has are: Best Graduating Student at St. Patrick's College, Asaba (1976), Most Efficient Senior Prefect (1976), Best Behaved Student (1976). Other awards include First Prize, John F. Kennedy Essay Contest (1975), Award for Excellence in academics by the 200 Foundation, Nigeria (1991); Certificate of Honour by *The Observer* Newspaper.

Professor Azinge is the initiator and Chairman, Board of Trustees of *Sojourners Medicare Foundation* – a charitable Foundation dedicated to offering instant medicare to accident victims on the highways. This is a passion he has pursued with vigour and determination. The first set of ambulances for this service have already been delivered. He is also the brain behind a number of scholarship Foundations – the most prominent of which is the Ugboma Azinge Scholarship Foundation.



D.G. NIALS PAYS A COURTESY CALL TO NATIONAL INDUSTRIAL COURT PRESIDENT

he Director-General of the Institute paid a courtesy visit to the National Industrial Court with some members of management. The entourage was received by the President of the National Industrial Court and Seven Judges.

The President of the National Industrial Court Justice Adejumo (OFR) in his speech expressed his delight at the visit and said in the thirty one years of inception of the Court, no Government Organization had paid them any courtesy visit. n the 26th May, 2009, Alhaji Umar Musa Yar'Adua, the President and Commander in Chief of the Armed Forces of Nigeria through the Honourable Attorney-General of the Federation and Minister of Justice, Chief Michael K. Aondoakaa,



The Ambulances poised for Dedication


